

RESOLUTION NO. 24-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
LANCASTER RECITING THE FACTS OF THE GENERAL
MUNICIPAL ELECTION HELD ON APRIL 09, 2024 AND
DECLARING THE RESULTS AND SUCH OTHER MATTERS
AS PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted in the City of Lancaster, California, on Tuesday, April 09, 2024 as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; and in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of all-mail-ballot elections in charter cities; and

WHEREAS, the City Clerk canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A."

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. The whole number of vote-by-mail voter ballots cast in the City was 13, 757. The whole number of provisional ballots was 17.

SECTION 2. That the names of the persons voted for at the election for Mayor are as follows:

That the measure, MEASURE C, voted upon at the election is as follows:

“Do you support the City of Lancaster exploring and potentially establishing a drug treatment program similar to Teen Challenge to address drug-related issues within our community?”

SECTION 3. That the number of votes given in the City to each of the persons named above for the respective offices for which the persons were candidates and for and against the measure were as listed in “Exhibit A” attached.

SECTION 4. The City Council does declare and determine that:

- R. Rex Parris was re-elected as a Member of the City Council for the full term of four years.
- Lauren Hughes-Leslie was elected as Member of the City Council for the full term of four years.
- Ken Mann was re-elected as a Member of the City Council for the full term of four years.

SECTION 5. The City Council submitted Ballot Measure C to the voters at the general all mail ballot municipal election held on April 09, 2024. Measure C was an advisory measure and without binding the city, would advise the City Council as to whether it should pursue a drug treatment program similar to Teen Challenge.

SECTION 6. The number of votes given for and against Measure C are as listed in “EXHIBIT A” attached. That as a result of the election, a majority of the voters voting on Measure C, did vote in favor of the measure.

SECTION 7. The City Clerk shall enter in the records of the City Council of the City, a statement of the result of the election, showing: (1) the whole number of votes cast in the City; (2) the names of the persons voted for; (3) the measure voted upon. (4) for what office each person was voted for; (5) the total number of votes given to each person; (6) the total number of votes for and against MEASURE C.

SECTION 10. The City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State

of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all the persons so elected shall then be inducted into the respective office to which they have been elected.

SECTION 11. The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
