1. Approval of Minutes from the Regular Meeting of October 21st, 2024

NEW PUBLIC HEARINGS

2. Tentative Parcel Map NO. 23-003 (84352)

Senior Planner, Kendall Brekke presented the staff report. Staff recommends approving a Tentative Parcel Map to subdivide the subject property into two commercial lots in the Commercial (C) zone within the Business Park Specific Plan.

There were no public speakers for this item.

Chairman Vose brought up concerns about CC&R; however, those are not overseen by Planning. No other comments from the Commission.

Commissioner Moore made a motion to Adopt Resolution No. 24-23 approving Tentative Parcel Map No. 23-003 (84352) for the subdivision of approximately 2.1 acres

into two commercial lots located at the northwest corner of Avenue K-4 and Sahuayo Street (APN: 3126-031-059) in the Commercial (C) zone within the Business Park Specific Plan and finding the project categorically exempt under the California Environmental Quality Act; authorizing staff to execute and file a Notice of Exemption. Vice Chairman Derryberry seconded the motion.

3. DRAFT PARKWAY VILLAGE SPECIFIC PLAN INTRODUCTION

Senior Planner, Kendall Brekke presented the Draft Parkway Village Specific Plan Introduction. Staff presented the draft plans, explaining that the plan aims to facilitate development for the next 30 years, and that all progress had been made possible through grant funding. At this stage, no specific developments are proposed. The conceptual drawings represent the City's vision for the potential use of the locations.

No action was required from the Commission.

Commissioner Moore raised concerns regarding the potential amphitheater and the associated parking issues it might cause. Kendall clarified that no official proposal for an amphitheater had been submitted; it is merely a possibility for the site. Chairman Vose inquired about the school site and its zoning, directing staff to confirm the requirements of the Lancaster School District. Chairman Vose stated that all existing non-conforming uses would be permitted to remain, ensuring that no legally established uses within the zone would be displaced. This matter is expected to be presented to the City Council in early 2025. Commissioner Underwood inquired about properties owned by international investors and the future of these properties. Chairman Vose responded that these properties would remain vacant as the City does not select developers or sites; developers choose the locations for their projects. Commissioner Birden also asked about the long-term plans for Kaiser, which was possibly suggested to be part of Phase 2 of the hospital. Additionally, the High-Speed Rail and the potential alignments along Sierra Highway were mentioned.

There was one speaker, Cynthia Underwood, who shared her concerns about the live/work space. Kendall stated this was a targeted area; however, more areas could be approved by staff if proposed.

COMMUNITY DEVELOPMENT ASSISTANT DIRECTOR ANNOUNCEMENTS

Hai Nguyen stated that the Planning Commission meeting in December would be canceled and reinstated in January.
