WHEREAS: Service Contract 50LP277, dated August 1, 2020, provided \$1,180,000.00 towards the Preliminary Engineering (PE) needed for roadway safety improvements at the grade crossing and intersection of Avenue M, the Union Pacific Railroad tracks, and the Southern California Regional Rail Authority tracks identified as California Public Utilities Commission (CPUC) No. 001B-409.10, 101VY-73.02/LA-1227, Federal DOT No. 750642H.

WHEREAS: Amendment 1: The project delays are due to the following; reviews from stakeholders for 60% and 90% PS&E took longer than originally anticipated and the diagnostic team suggested modification of scope and additional design options to finalize the preemption timing. Therefore, the local agency has requested additional time and funds to complete the final design. The service contract will be extended for three (3) additional years from June 30, 2025 to June 30, 2028 with additional funds in amount of \$50,000.00.

NOW THEREFORE, it is mutually agreed by the parties hereto; that all terms and conditions of Service Contract 50LP277 as amended shall remain in full force and effect, except the contract dollar amount shall be amended with \$50,000.00 of additional funds for a total contract value of \$1,230,000.00, and the Expiration Date shall now be June 30, 2028.

RESOLUTION NO. 14-70

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, RESCINDING RESOLUTION NO. 00-251 AND AUTHORIZING THE CITY MANAGER TO APPROVE AND SIGN ALL MASTER AND PROGRAM SUPPLEMENTAL AGREEMENTS WITH THE STATE OF CALIFORNIA FOR STATE AND FEDERALLY FUNDED TRANSPORTATION PROJECTS.

WHEREAS, the State of California and the Federal Highway Administration make funds available through local programs to the City for use on local transportation facility projects; and

WHEREAS, the City is required to enter into an agreement with the State, referred to as the Master Agreement, defining the general terms and conditions which must be met in order to receive Federal or State funds; and

WHEREAS, Program Supplements to the Master Agreements are required to be approved for every specific project that is to receive the funds; and

WHEREAS, an authorized agent for the city can be designated to approve and sign all Master Agreements, Program Supplemental Agreements and any other documents pertaining to the implementation and payment of funds to facilitate a more efficient process; and

WHEREAS, on October 10, 2000, the City Council adopted Resolution No. 00-251, designating the Director of Public Works as the authorized agent to approve and sign all Master Agreements, Program Supplemental Agreements and related documents; and

WHEREAS, the City Council desires to rescind Resolution No. 00-251 and designate the City Manager as the authorized agent for such agreements.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LANCASTER DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. The foregoing recitals are true and correct and are a substantive part of this Resolution.

Section 2. Resolution No. 00-251 is rescinded effective immediately.

Section 3. The City Manager of the City of Lancaster, or his designee, is designated as the authorized agent for and on behalf of the City of Lancaster to approve and sign all Master and Program Supplemental Agreements as well as all other documents pertaining to the implementation and payment of Federal and State funds for transportation projects.


