#### **CALL TO ORDER**

Chairman Jim Vose called the meeting to order at 3:31 pm.

### **1. Approval of Minutes from the Regular Meeting of January 27<sup>th</sup>, 2025**

## **NEW PUBLIC HEARINGS**

### **2. Conditional Use Permit No. 25-004**

Planner, Mitzi Alvarado, presented the staff report. Staff recommends adopting Conditional Use Permit (CUP) No. 25-004 for a new bona fide restaurant (Fairway's Pub) with a Type 41 ABC license to operate with a virtual golf entertainment simulator in a 2,600 square-foot tenant space in a commercial center (Somerset Village) at 1915 West Avenue L (APN: 3125-014-017) in the Commercial Planned Development (CPD) zone.

There were no public speakers for this item. An uncontested letter from the applicant was provided on the day of the meeting.

Commissioner Carrillo asked about the hours of operation and noted that it is a family restaurant. He also inquired about deliveries, which will be made through the main entrance. Vice Chairman Derryberry wished the applicants good luck and asked if they knew who the previous tenant was. The space has been vacant for some time, so it was uncertain. Chairman Vose asked about the kitchen floor plan, pointing out that there was

no stovetop despite food being offered. The applicant, Tom Sanchez, explained that all food-related equipment is ventless for fire suppression. He mentioned that additional coordination with the fire department would be needed if grills or expansions are added in the future. The proposed deep fryers are exempt from fire department approval. Chairman Vose emphasized that no other forms of entertainment are planned on-site beyond what has been proposed. Commissioner Moore inquired about the electrical company for the project, to which Mr. Sanchez confirmed that an electrician had reviewed the plans.

Vice Chairman Derryberry, made a motion to Adopt Resolution No. 25-02 approving Conditional Use Permit No. 25-004 to allow for a new bona fide restaurant (Fairway's Pub) with a Type 41 ABC license to operate with a virtual golf entertainment simulator within a 2,600 square-foot tenant space in a commercial center at 1915 West Avenue L (APN: 3125-014-017) in the Commercial Planned Development (CPD) zone and finding that the project is categorically exempt under the California Environmental Quality Act; authorizing staff to execute and file a Notice of Exemption. Commissioner Birden seconded the motion.
