

ORDINANCE NO. 1092

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LANCASTER AMENDING TITLE 2 (ADMINISTRATION AND PERSONNEL) OF THE LANCASTER MUNICIPAL CODE BY REPEALING CHAPTER 2.28 (“YOUTH COMMISSION”), CHAPTER 2.34 (“ARCHITECTURAL AND DESIGN PLANNING COMMISSION”) CHAPTER 2.37 (“LANCASTER HOMELESS IMPACT COMMISSION”), AND CHAPTER 2.38 (“LANCASTER HEALTHY COMMUNITY COMMISSION”)

WHEREAS, the City Council of the City of Lancaster finds that several commissions that have been established do not require regular monthly meetings; and

WHEREAS, the City Council further finds and declares that, from time to time, creating ad hoc committees for special issues to include persons with expertise in the issue as well as community stakeholders will be a more productive and nimble method of gathering the individuals most likely to achieve desired outcomes on a specific issue; and

WHEREAS, the City Council further finds and declares that existing commissions and ad hoc committees can efficiently address the issues that come before the Youth Commission, the Architectural Design and Planning Commission, the Lancaster Homeless Impact Commission, and the Lancaster Health Community Commission;

THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Lancaster Municipal Code Title 2 is hereby amended by repealing the following chapters:

Chapter 2.28 (Youth Commission)
Chapter 2.34 (Architectural Design and Planning Commission)
Chapter 2.37 (Lancaster Homeless Impact Commission)
Chapter 2.38 (Lancaster Health Community Commission)

SECTION 2. Ad hoc committees shall be created as needed from time to time in accordance with Chapter 2.32 of the Lancaster Municipal Code.

SECTION 3. That the City Clerk shall certify to the passage of this Ordinance and will see that it is published and posted in the manner required by law.
